PRESIDENT'S ANNUAL ADDRESS

Members of the Woman's Auxiliary of the Diocese of Albany:

The reports which you have heard speak more eloquently than it would be possible for me to do of the great amount of good work carried on in our Auxiliary during 1928. Nor shall I dwell upon the outstanding events of that year, such as the visit of the Presiding Bishop, and the retirement from the presidency of Mrs. Grey, who took with her our deepest esteem and warm appreciation of what she had been to our Auxiliary. We have abundant cause to be gratified with our record for the year; and yet there is another thought which suggests itself. Should not each parish find out in just what ways improvement may be made? Can we not enlarge our membership, interest the young women more successfully, increase our giving, and in other particulars make an advance? I trust that we shall all do this, and so, in the new year, accomplish even more than before. It is rather of that which has been happening since January 1st, the date at which our reports close, that I would speak.

On the afternoon of January 10th many members of our Auxiliary gathered in the choir of the Cathedral for a Quiet Hour, conducted by Dean Richardson. The peaceful, helpful nature of such services, calling us to step aside for a short time to listen, to think, and to pray, should commend them to us; and I hope that in the future all members of the branches in Albany, Troy, and other towns nearby will come together, at least once a year, for this refreshment of spirit.

Late in January an appeal was made to all Auxiliary members, as individuals, to promote the great effort, just starting, for St. Luke's Hospital, Tokio, and I doubt not that it called forth a warm response. In addition to what was given by our members severally, no fewer than eight Auxiliaries sent contributions as branches. The total amount given so far by the diocese is \$12,432.75.

We have been favored with visits from Mrs. Wyllie, wife of Archdeacon Wyllie, of Santo Domingo, and from Mrs. Charles H. Boynton, of New York, our Provincial Representative on the National Executive Board. The former came to us early in March, and spoke most eloquently of the work at Santo Domingo before the branches of Albany and vicinity at St. Peter's Church, and of Troy and vicinity at St. John's Church. A fine meeting was also arranged for her at the Church of the Messiah, Glens Falls. She carried away with her substantial proof of our interest in the furnishing of the new church, for the building of which we have, as a diocese, already raised our quota. Mrs. Boynton, from April 11th to 15th, addressed three fine meetings at the Cathedral, Albany; St. Paul's, Troy; and St. George's, Sc'

tady, on the work of our National Executive Board, and on our Church's missions in Mexico. She came in a most friendly way, desirous of making acquaintance with us whom she represents.

In March, Miss Lindley kindly offered to send us Mrs. Arthur Gammack, a United Thank Offering worker, who should travel about the diocese at no expense to us, holding meetings where desired, with the object of stimulating the interest of our parish branches. Mrs. John S. Conover was appointed by Bishop Oldham to confer with Mrs. Gammack and arrange her tour. This she has done with the aid of our managers, who have arranged meetings in the different archdeaconries. Mrs. Gammack has already been with Mrs. Rodgers and Mrs. Livingston in the two divisions of the Archdeaconry of Albany, and with Mrs. Bridges and two divisions of the Archdeaconry of the Susquehanna. Beginning her tour on April 8th, she will be with us until June 1st, and hopes to cover the whole diocese.

As diocesan president, I have been asked by the Department of Missions to appoint a committee for recruiting. This work, appearing to be one appropriate for our managers, I have turned to them, and Mrs. Henry D. Rodgers, one of their number, has kindly consented to act as their chairman for this purpose. Lists of nurses, teachers, and secretaries, needed in the mission field, have been sent to the managers, and placed in hospitals and vocational training colleges in Albany, Troy, and Schenectady. I also made an appeal to an Institute of Nurses, in session in Albany. This need of workers in our mission fields is constant; and I would ask most earnestly for the help of all in finding such workers and reporting them to Mrs. Rodgers, and in encouraging young women to offer themselves for this blessed service.

Literature in regard to designating the Good Friday offering in our churches to work in Jerusalem, having been sent me from headquarters, I distributed it to the parish presidents, urging them to lay the matter before their rectors. At the same time, I sent each president a copy of the resolution on Personal Religion and Evangelism, passed by the delegates at our Triennial, with other printed matter bearing on the same, and offered some suggestions as to their use.

At this, our annual meeting, it is proper that we should pause and think of one who was for long a most active and valued member of the Cathedral branch, and for one year, 1910-1911, president of the Diocesan Auxiliary Board. Mrs. Samuel B. Ward, who passed to her rest a few weeks ago, is mourned and will be remembered as one whose loyal nature and gracious, unselfish ways made her many friends. This meeting, too, is not without sadness as it brings us to the parting with some who have served with us devotedly and are now retiring. Miss Ruth Hall, who for fourteen years has been our Educational and Extension Secretary, brought to her task a gift of literary expression

which made her reports delightful. She greatly increased the number of study classes and, though the interest in them seemed to decline during the Great War, there are now a few less than forty to report. The number of corporate communions doubled during the past year. Mrs. John H. McElroy, who for two years has been our kindly and efficient Recording Secretary, is also laying down her work. We extend our most grateful acknowledgement to them both, and pray God's blessings upon them. Mrs. Harl Hood, who now becomes our Educational Secretary, has made so fine a record as Box Secretary as to give promise of successful efforts in her new field. Her unexpired term as Box Secretary will be filled by appointment, as provided for in our by-laws. We are very glad to welcome to our Board as Recording Secretary, Mrs. Frank B. Twining, of Trinity Parish, Troy.

And now for a brief glance at the immediate future. We hope to commence our work next October with a Quiet Hour in the Cathedral. Miss Lindley has given us the confident hope that she will come and conduct it for us, and I trust that we may gather, in great numbers, to ask God's guidance in our new undertakings. Our semi-annual meeting will be held later at Christ Church, Hudson. Also, this year, the Provincial Synod will meet in Albany in November. The sessions of the Woman's Auxiliary on this occasion are sure to be valuable, and as many of our members as possible should attend them.

A short time ago I read with deep interest a letter written in the early days of the late war by the great Frenchman, Marshal Foch. It was dated September 20, 1914, and addressed to a retired general with whom, for a quarter of a century, he had been in close and affectionate relations. To this old friend he told with what great difficulties he had struggled when he went to take command of the division of the army assigned to him. He found this great body of men in full retreat before the enemy, and their condition so demoralized and distressing as to constitute a rout. For several days he bent all his power to rallying and encouraging them until they were again able to take the offensive and, after five days of terrible fighting, to gain the victory. In speaking of this, the great general did not glory in the ground they had conquered nor the number of the enemy killed or made prisoners. It was the restored courage and morale of his men which filled him with satisfaction. "Ah," he exclaimed, "how beautiful is victory from the point of view of confidence." Now these French soldiers had excellent military training, they had their captains, majors, colonels and corp commanders to lead them, and they had the deepest of all motives to fight, the defense of their native soil and of their families. But all this did not prevent them from suffering a disastrous defeat. It was only when their Supreme Commander came among them, and they felt the strength of his spirit inspiring them, that they were able to

take courage and, rallying, to gain the victory. I like to think of our Woman's Auxiliary throughout the country as forming a brigade in the great army of Christ's followers in every church and in every nation, who are engaged in the great war against evil, and to make the Kingdom of God prevail upon earth. We have our leaders and our machinery and organization, but it is only by our faith in, and our devotion to, our Supreme Commander, Jesus Christ, that we shall be enabled to gain the victory.

MINUTES OF THE ANNUAL MEETING

The Annual Meeting of the Albany Diocesan Branch of the Woman's Auxiliary was held at St. John's Church, Cohoes, May 1st and 2nd, 1929. The meeting opened with a service in the church on the evening of May 1st, with Bishop Nelson as the preacher. It was with intense regret that the members realized that this would be the last time he would address them as their bishop.

The Holy Communion was celebrated Thursday morning by the rector, the Rev. E. J. Hopper, assisted by the Rev. J. A. Springsted, of Glens Falls.

The business meeting was called to order at ten o'clock by Miss Sarah B. Tibbits, the president. Miss Lindley offered the opening prayer, and Mr. Hopper welcomed the delegates on behalf of St. John's parish, and announced that this was the ninety-eighth anniversary of the church. A rising vote of congratulation was proposed by Miss Tibbits and carried by all present.

The minutes of the semi-annual meeting were read and accepted. The treasurer's report showed a balance on hand, January 1st, of \$229.69. Mrs. Conover reported for the United Thank Offering, \$2,846.90. Mrs. Conover urged that \$20,000 be the goal of the next Triennial, and asked each auxiliary member to secure one additional box contributor.

Mrs. Crydenwise, corresponding secretary, reported one hundred and thirty-three letters written, many articles contributed to the Albany Churchman, and notices of the annual meeting sent out. She urged that the members preserve the copies of the constitution in this year's year-book. Mrs. Hood, box secretary, announced her resignation, and presented her report for the year, showing satisfactory progress.

Miss Hall presented her final report as educational secretary, and expressed the joy which her fourteen years of service had been to her. Mrs. F. Herbert Grey presented the following resolution, which was carried by a rising vote:

"Resolved, That the Woman's Auxiliary of the Diocese of Albany, in annual convention assembled, record its affectionate recognition and deep appreciation of Miss Hall for her fourteen years of unbroken and loyal service as Chairman of the Extension Committee and Educational Secretary."

Mrs. Hubbard reported for the Church Periodical Club a year of progress and increased interest. Miss Strong's report on altar furnishings closed the list of reports, and each was formally accepted.

Miss Tibbits announced that she wished to make an appeal for two objects,—one the reserve fund, and the other the provincial

scholarship. Mrs. Lochner presented the appeal for the reserve fund, explaining that the plea was for \$50, to reimburse the treasury for money borrowed for the corporate gift. The response was so prompt and generous that it was almost impossible to record the pledges. These amounted to \$134. Mrs. Conover then made a plea for the provincial scholarship, which goes to Bishop Carson in Santo Domingo for the training of young men, and \$63 was pledged.

The report of the nominating committee was called for and was presented by Miss Townsend, as follows: For educational secretary, Mrs. Harl E. Hood; for recording secretary, Mrs. Charles W. Nash, of Albany. Mrs. Frank B. Twining, of North Troy, was nominated from the floor for recording secretary by Miss Strong. Ballots, and a leaflet containing the minutes of the last Triennial, were then distributed to the delegates. The latter were the gift of Miss Tibbits to all branch presidents, and she urged the presidents to read them carefully and use them at Auxiliary meetings.

The president then gave her report. She spoke of the good fortune of the diocese in having had so many of the national secretaries visit us during the past year. She made a strong plea to the parishes to help the managers in their efforts to recruit more workers in the mission field—nurses, teachers and secretaries. She also made an appeal for a wider circulation of the Spirit of Missions in the diocese.

Prayers for missions were read by Mr. Hopper. He announced that \$50 was contributed at the evening service, and \$115.14 at the morning service.

Miss Lindley, national executive secretary, was then presented and gave a fine address, telling of the work of the Church in Mexico, Panama, Santo Domingo, and Porto Rico.

The nominating committee reported that Mrs. Harl E. Hood was elected educational secretary, and Mrs. F. B. Twining, recording secretary. The meeting then adjourned for luncheon.

After luncheon the president called on Miss Townsend, who said that it had been suggested that each branch be asked to express its feeling on whether the number of delegates should be limited, so that it would be easier for smaller parishes to entertain the convention. It was decided to have the corresponding secretary write the branches on this matter.

Christ Church, Hudson, extended an invitation to hold the semi-annual meeting there, and the invitation was accepted with thanks. Mrs. Twining moved that a rising vote of thanks be given St. John's Auxiliary and the rector for their delightful hospitality, which was carried unanimously. The meeting then adjourned.

MINUTES OF THE SEMI-ANNUAL MEETING

The Semi-Annual Meeting of the Albany Diocesan Branch of the Woman's Auxiliary was held at Christ Church, Hudson, October 30th and 31st.

At four o'clock on Wednesday afternoon Mrs. Hood conducted a very helpful and instructive conference on educational work and discussion classes. There were twenty-two present. It was decided to have an educational day in February.

At the evening service the Rt. Rev. Thomas Jenkins, of Nevada, was to have addressed the Auxiliary, but illness prevented his being present. Dean Richardson took his place and gave a most interesting address on "The Aims of the Work."

The Holy Communion was celebrated on Thursday morning by the rector, the Ven. C. R. Quinn, assisted by Archdeacon Purdy.

The regular business meeting was opened at ten o'clock by the president, Miss Tibbits. The minutes of the annual meeting were read and approved. Mrs. Lochner, treasurer, reported a balance on hand Nov. 1st, 1929, of \$849.11. Mrs. Conover reported that the United Thank Offering to date amounted to \$6,259.98.

Mrs. Crydenwise, corresponding secretary, asked that the branches be prompt in sending in their reports, so that the year-book might be ready for the printers early in March. She reported that the W. A. page in the Albany Churchman had been regularly supplied with news items; that, since the annual meeting, ninety-four letters had been written, and forty-three minutes of the Triennial, 218 post cards, 225 programs, and twelve copies of the annual report had been mailed; also that several letters had been forwarded to the proper persons,—altogether 500 pieces of mail handled.

Mrs. Harrington, box secretary, reported forty assignments sent out, and twenty-five accepted. She stated that this year's allotment for box work is for four missionaries and families, one catechist, seven women missionaries, and four missions, a total of 2,000 individuals for whom we are asked to work. Second-hand clothing is asked for men, women, boys, girls, and babies, and branches are especially asked to remember the elderly men.

Mrs. Hood, educational secretary, spoke of the educational conference and of the program. She urged the use of the program, in whole or in part, as adapted to the individual parish needs. She also spoke of the increased interest in the discussion classes and educational work, and of the many parishes adopting the program. Mrs. Hood was most generous in offering her services to all who wished to ask questions or desired help.

Interesting reports were made by Mrs. Rodgers and Mrs. Livingston, managers of the first and second districts of the archdeaconry of Albany, telling of the work done in the many parishes, and of the benefits resulting from Mrs. Gammack's visit. All reports were accepted as read.

Mrs. Sibley gave a most vivid, interesting and instructive talk on the Jerusalem Conference, bringing the atmosphere and messages of the Conference to us, and inspiring the discussion groups and all listeners to more intensive study. Miss Tibbits, in her address, gave some very pertinent figures as to the parishes, their numbers and the work done.

The roll call showed thirty-eight parishes represented, 202 delegates, and a total attendance of 275. Bishop Oldham said the noon-day prayers, and following the prayers, spoke on the synod program. He then introduced Bishop Campbell, of Liberia, who gave a most interesting talk on the work and conditions in Liberia, and spoke of the very grave conditions caused by the decrease in the mission allotments, and what it meant in the mission fields.

An appeal was made for two scholarships, and \$31 was pledged for the Bishop Doane scholarship, and \$10 for the Mary H. Rochester scholarship. Mr. Quinn reported that the evening offering amounted to \$30.78, which by unanimous vote was given to Bishop Campbell. Mrs. Conover reported \$26.10 for the United Thank Offering. Miss Arnold spoke on the National G. F. S. and its cooperation with the Woman's Auxiliary work.

Mrs. Conover presented the following resolution, which was adopted unanimously by a rising vote:

"Resolved, That the Woman's Auxiliary of the Diocese of Albany, assembled for their semi-annual meeting in Christ Church, Hudson, extend their deepest sympathy to Mrs. Murray in the great loss that has come to her and to the whole Church in the death of our beloved Presiding Bishop. We remember with loving gratitude the privilege that was ours in the spring of 1928, when Bishop Murray was with us at our annual meeting, held in All Saints' Cathedral, Albany, when he gave to us the inspiration of his presence; and we pray that the benediction of his Christlike and saintly life may remain with us, as we strive to carry on the work for which he lived and died."

The meeting then adjourned for luncheon, when the experiment of a box luncheon proved a great success.

Miss Tibbits again called the meeting to order at 2:15 for unfinished business. Parish work was discussed. Miss Rawdon offered a resolution of thanks to the Woman's Auxiliary and the rector of Christ Church for the hospitality so cordially extended to the diocesan

branch. The meeting adjourned, closing a most interesting conference of work done and of help to do more and better work.

REPORT OF CORRESPONDING SECRETARY

During the past year I have written over two hundred letters; and if I were to count them, I have probably received at least three-fourths of that number. I have mailed 404 postcard notices of the annual and semi-annual meetings, and also the same number of programs, as well as forty-three copies of the minutes of the Triennial.

Ninety-three blanks have been sent to branch officers for data for the annual report. In this connection I wish to say that, for the first time in the five years that I have been corresponding secretary, I have heard from every branch.

I have attended to the publication of the annual report, and have distributed more than seven hundred copies. I have also written or secured material for ten issues of the Albany Churchman.

Branch officers should note that the constitution is not published in this year's annual report, so that last year's copy should be carefully preserved for reference.

REPORT OF THE EDUCATIONAL SECRETARY

The educational work for this past season was opened with the mailing of a Suggested Program for the women of the diocese. This program was well received, and several branches reported its adoption.

A conference was held in Hudson prior to the semi-annual meeting. It was well attended, and there was a great interest shown in the plans which were discussed; also, a large amount of missionary literature was sold.

The secretary has had the privilege of speaking on the educational work before two parish branches.

Reports on the year's work have been received from sixty-eight branches, and the summing up of these is the most interesting part of this report, for it is what you have done, and that is what counts.

There have been nine discussion groups and twenty-three study classes. Thirty-three branches have had program meetings, six have had Bible classes, and nine, reading circles.

There has been an increased interest in speakers, and forty-two branches report speakers from outside the parish; also, forty-two branches have had members attending meetings outside their parish.

Four women attended summer schools; eleven branches have missionary book shelves; twelve have representatives for the Spirit of Missions; and six branches have placed the Spirit of Missions in their public libraries.

The report on the devotional life of the branches shows that there have been seventy-two corporate communions, and sixteen devotional days; seven branches have prayer groups; and there are one hundred subscribers to the Prayer Leaflet.

The secretary for the Church Missionary Calendar writes me that the sale of this calendar has trebled in this diocese this past autumn, and it is being used as a basis for short programs in many branches.

REPORT OF CHURCH PERIODICAL CLUB

The Church Periodical Club reports a profitable year. There has been an increase of 117 magazines forwarded regularly from 162 new donors, and we have distributed 124 more books than last year, making a total of 623. Five new branches were welcomed, from St. Stephen's Elsmere, St. Mark's, Malone, St. John's, Troy, St. Margaret's, Menands and Trinity, Troy; all of which have shown interest and enthusiasm in the work.

Twenty-seven institutions in the diocese have been aided, and the Rev. R. C. Joudry has been given many books and magazines for his rural work. We had the privilege of helping the Rev. Frank Blessing renew his library after his destructive fire; and we have provided the Rev. W. Hubert Bierck and his family with the books and magazines necessary to their comfort during their stay in the Philippine Islands.

This coming year brings the promise of several new branches, and the privilege of work for the isolated under Archdeacon Purdy. We are undertaking a campaign for the year, our slogan being "1000 Magazines!" By working together, we can attain the goal with certainty, and will then feel that we are standing in the first ranks of diocesan C. P. C. work. It is with mingled feelings of pride and humility that the director submits her report—pride in the leadership of a group of such faithful secretaries and members, and humility before the fact that she has done so little to further the rich results of the past year.

DIRECTIONS FOR PARISH OFFICERS

Finances

The annual Branch Fee (minimum, \$2) is due in January of each year. The Parish Treasurer should send this to the Diocesan Treasurer as early in the year as possible, and other moneys as soon as they are in hand.

Gifts for the United Thank Offering should be sent to the Treasurer of that fund; those for the Church Periodical Club, to the Diocesan Director of that organization; and special gifts to churches and charities not under the Department of Missions of the National Council should be sent direct to the recipients.

In remitting funds for the United Thank Offering, checks should be made out to, "United Thank Offering, Albany Diocese."

Box Work

Always mention the name of your parish, your city or town, and the date of writing, in every communication.

The Box Secretary of the Diocesan Branch receives, in August, the allotment of Box Work for the Diocese. When your branch is ready to start work write to the Diocesan Box Secretary for an assignment.

When your branch has voted to undertake the work assigned to it, notify at once, the Box Secretary, and the missionary for whom the box is to be prepared.

All rejected assignments must be returned to the Box Secretary without delay.

When boxes are shipped, write to the missionary to whom it is addressed, and also send a report to the Box Secretary on the authorized blanks.

No requests for additional **new** articles should be accepted by branches unless approved by the National or the Diocesan Box Secretary. This is to avoid duplication.

No credit can be given for boxes unless the work has been assigned by the Box Secretary.

Education

The Educational Secretary sends out each year to all branches in the Diocese two questionnaires, one during the first week in September, and another on February 1st. The replies to these are her sources of information for the reports she must make to the annual and semi-

annual diocesan meetings, and to the Church Missions House at the beginning of the year. Auxiliary Presidents are urged to fill out these questionnaires fully and promptly, and thus help, and not hinder, the work as a whole.

Periodicals, Furnishings

All boxes of books, single books, and magazines, should be reported through the Church Periodical Club.

All requests and gifts for altar furnishings should be sent to the Chairman of the Committee on Altar Furnishings.

Reports, &c.

Always notify the Corresponding Secretary promptly of any change of branch officers during the year.

A yearly report of all pledges paid, work, study, and methods, should be sent to the Manager of your Archdeaconry Division.
